Waiver, Liability Release, Covenant Not To Sue, and Image/Audio Release

In consideration of being allowed to participate in the 2017 Chesapeake Voyaging Expeditions, MASCF XXXIV, I acknowledge, appreciate, and agree that:

1. I hereby attest that I am fully cognizant that the dangers and risks incurred due to participation in any Chesapeake Voyaging Expedition are significant and include, but are not limited to, the following; drowning, near-drowning, sprains, strains, fractures, heat and cold injuries, over-use syndrome, injuries involving vehicles, food poisoning, animal bites and stings, contact with poisonous plants, burns, accidents involving, but not limited to, paddling, swimming, hiking, portaging, travel by boat or other convenience, and there is potential for permanent paralysis, death, loss at sea, or wandering the wilderness. While particular rules, equipment, and personal discipline may reduce this risk, the risk of consequences still exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION; and,
3. For myself, my executors, administrators, heirs, next of kin, successors, guests, personal representatives and assigns, I HEREBY: a) WAIVE, RELEASE, INDEMNIFY, AND HOLD HARMLESS CHESAPEAKE BAY MARITIME MUSEUM, their officers, event committee, voyage managers, agents and/or employees, hosts, sponsors, supporters, advertisers, volunteers, and if applicable, owners and leasers of premises used to conduct the event or activity or related activities ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, OR DEATH, or loss or damage to person or property, including any costs due to attorney fees that may be incurred as a result of any such claim whether valid or not, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, arising from participation in this event or related activities
4. I hereby attest and verify that I am physically fit and have sufficiently trained and am in mental condition to participate in this voyaging event.
5. I hereby attest and verify that I possess the proper skill set to participate in this event and related activities safely.
6. I hereby agree that the Releasees reserve the right to postpone, cancel or modify any event or activity for any reason what so ever or for no reason.

I also grant the use of my voice and any and all recorded and or filmed/video/photographed footage of me, and further waive all rights to any compensation, as a result of my name, voice, or likeness being used in any way.
